## **Brobson for Supreme Court Trusted. Tested. Fair.**

HARRISBURG, PA – Commonwealth Court President Judge Kevin Brobson today formalized his candidacy for Pennsylvania Supreme Court justice.

“All Pennsylvanians deserve to have faith in a fair and impartial judiciary,” said Brobson. “I entered this race to offer a new voice and new perspective for Pennsylvanians on the Pennsylvania Supreme Court.”

Brobson is the endorsed candidate for Supreme Court by the Pennsylvania Republican Party. Born and raised in Lycoming County, he is the son of a retired Pennsylvania state trooper and grandson of former Philadelphia police officer. “Growing up in North Central Pennsylvania, my parents instilled in me the importance of public service and the mantra that there is no substitute for hard work,” said Brobson. “Our Commonwealth needs people willing to serve in the public interest, to work hard, and to do what is right under the law.” Brobson and his wife Lauren live in a rural community just outside of Harrisburg, Pennsylvania, with their three children.



Upon completing a federal judicial clerkship in Philadelphia, Brobson entered private practice with the Pittsburgh-based law firm Buchanan Ingersoll & Rooney PC, where he practiced for 14 years and was promoted to shareholder and practice group leader. Brobson was elected to the Commonwealth Court in 2009, retained in 2019, and chosen by his colleagues in December 2020 to serve as the 10<sup>th</sup> president judge of the Commonwealth Court. The Pennsylvania Supreme Court appointed Brobson to a four-year term on the Pennsylvania Judicial Conduct Board. During his term, the members of the Board elected him to serve as secretary and then chair.

The Pennsylvania Bar Association Judicial Evaluation Commission awarded its highest rating to Brobson’s candidacy for the Pennsylvania Supreme Court—“Highly Recommended”—based on his “commitment to the citizens of Pennsylvania, combined with the high degree of respect and trust of his colleagues and his demonstrated excellence and integrity in his jurisprudence from the bench.”

Brobson’s campaign is chaired by former U.S. Attorney for the Middle District of Pennsylvania David Freed. “Kevin brings the kind of experience and integrity Pennsylvania needs on our highest court, along with a statewide reputation for fairness and impartiality” said Freed. “Kevin’s candidacy

represents the best Pennsylvania has to offer in public service and judicial competence, combined with the perspective of a hardworking father, husband and son.”

Retired Pennsylvania Superior Court Judge Robert Graci, who also previously served as Chief Counsel to the Pennsylvania Judicial Conduct Board, is the campaign’s treasurer.

“Like the decisions of the Commonwealth Court, the decisions of the Pennsylvania Supreme Court impact the lives of all Pennsylvanians,” said Brobson. “The outcome of this race will have a generational impact on how we educate our children, care for our elderly, protect our historic and natural resources, and elect our public officials. I am honored that these two respected public servants and trusted professionals said ‘yes’ to my candidacy and this campaign for Pennsylvania’s future.”

The Commonwealth Court of Pennsylvania is one of Pennsylvania’s two statewide intermediate appellate court, only one step below the Pennsylvania Supreme Court. Drawing on his 11 years of experience as a Commonwealth Court Judge, Brobson said he will be a justice who holds government just as accountable to the law as the government holds its citizens.
